

TFP Contract & Media Release

TFP = "Trade for Photos" In this instance, we are trading your time as a model for x-amount of professionally rendered digital photographs

This photoshoot is a collaborative art-share. My intension is to have fun, explore my craft, and engage in the creative process with you. This TFP agreement was created to help make that possible.

TFP Agreement

* A minimum of 3 edited photos per 1 hour of Model's time will be provided. Additional photos provided above the minimum stated are at the discretion of the Photographer(s). Initial here that you understand and agree this: _____

* I will be selecting all final photos to be edited. There will not be a gallery of the entire shoot provided at any time. If there is a particular photo you wish to restrict, you may contact me within a week of our shoot, but you may not renegotiate permissions once they have been given. Please be mindful and respectful of both of our time. Initial here that you understand and agree this: _____

* **Do you have any questions or concerns about working with a male photographer? If so, please address below so we can co-create a fun, safe experience for everyone.**

Professionalism will be practiced throughout the duration of our shoot, the editing process, the delivery of content, and through the duration of this contract agreement. If at any time you feel uncomfortable or unsafe, **it is your responsibility to voice your concerns**. This contract was created to help with that, but you are ultimately responsible for your choices. If you will not be able to voice your needs during the photoshoot, I request that you bring an advocate.

* **Advocate's contact info:**

Please do not partake of drugs, alcohol or mood enhancers before or during the shoot. These mind-altering substances will not be provided. This is to ensure everyone is present and making conscious decisions each step of the way. Thank you for respecting this policy.

All sessions with partial or full nudity will require a second person present at all times. If they become unavailable for any reason, the shoot will need to be rescheduled. You are responsible for all makeup, hair and wardrobe accessories. If you need help with those on set, I request that you bring an assistant, as no one will be physically touched by me or my lighting assistants, unless they are in physical danger or there is a medical emergency.

Media Release:

I hereby grant permission to the rights of my image, likeness and sound of my voice recorded as audio or video without payment or any other consideration. I understand that my image or voice may be edited, copied, exhibited, published or distributed and waive the right to inspect or approve the finished product wherein my likeness appears. Additionally, I waive any right to royalties or other compensation arising or related to the use of my image or audio/video recording. I also understand that this material may be used in promotional settings within an unrestricted geographic area.

Photographic, audio or video recordings may be used for the following purposes:

- Promotional, creative, artistic, marketing and sales for **Abram R. Katz Productions**
- Licensing and public display of all media collected by **Abram R. Katz**

By signing this release form, I understand this permission signifies that photographic, audio or video recordings of me (or my child where applicable) may be electronically displayed via the Internet or in a public setting. I will be consulted about the use of photographs, audio or video recordings for any other purposes than those listed above.

There is no time limit on the validity of this release nor is there any geographic limitation on where these materials may be distributed.
